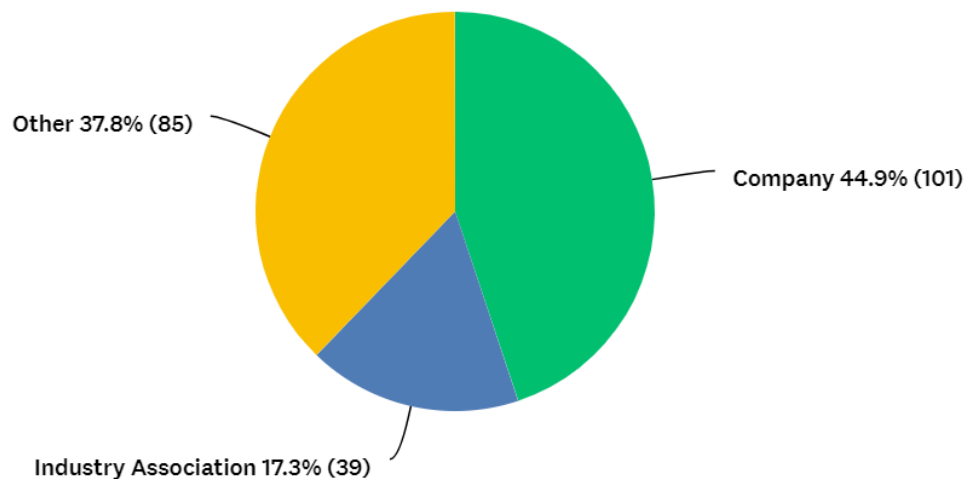

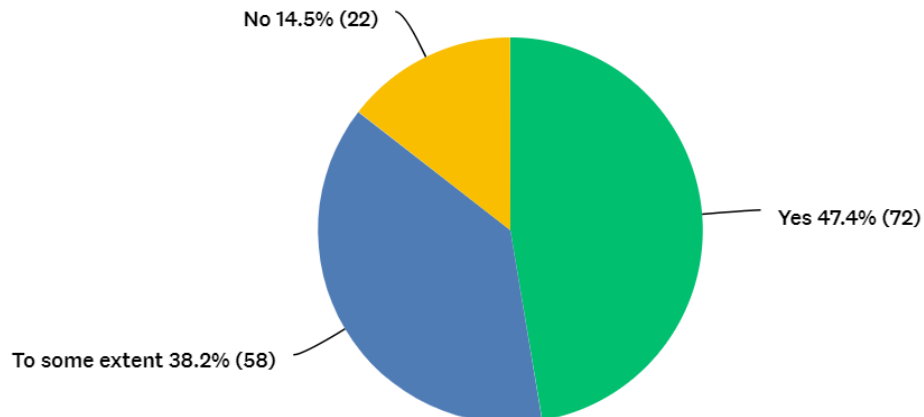
**How familiar are you with the Global Framework on Chemicals adopted in 2023?**

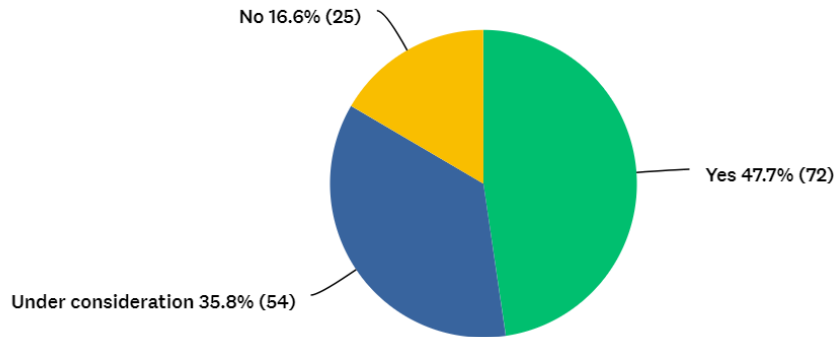

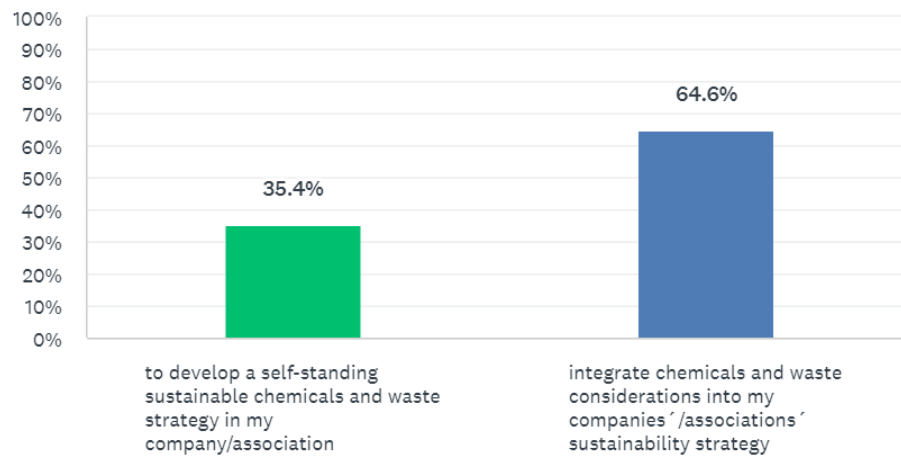

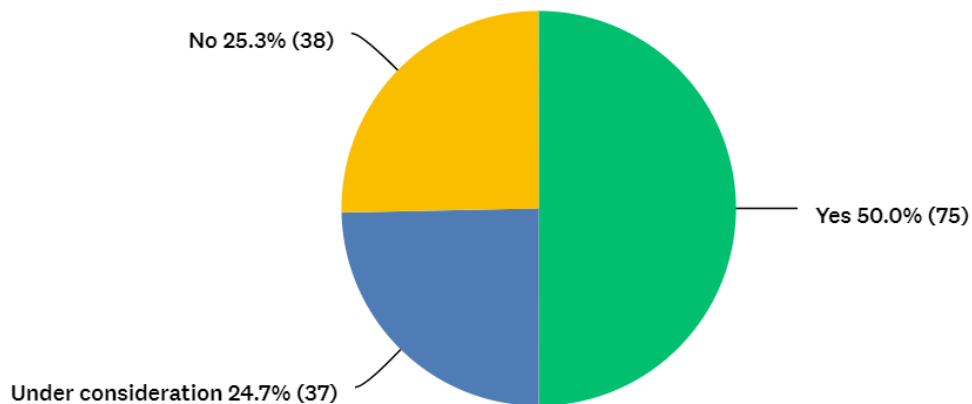

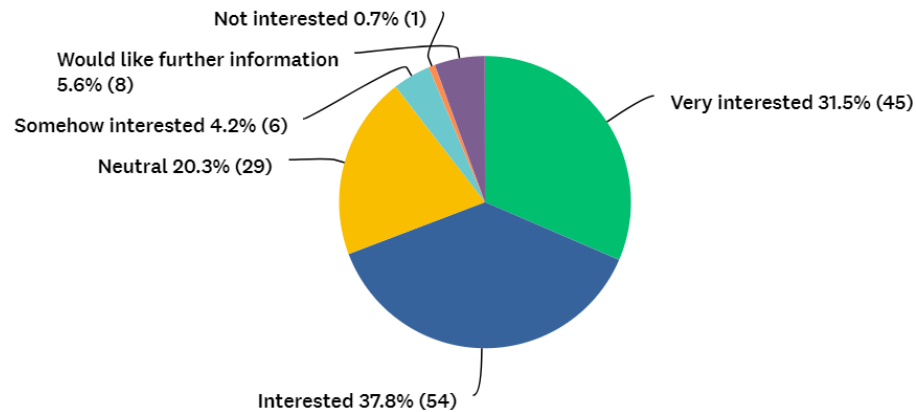

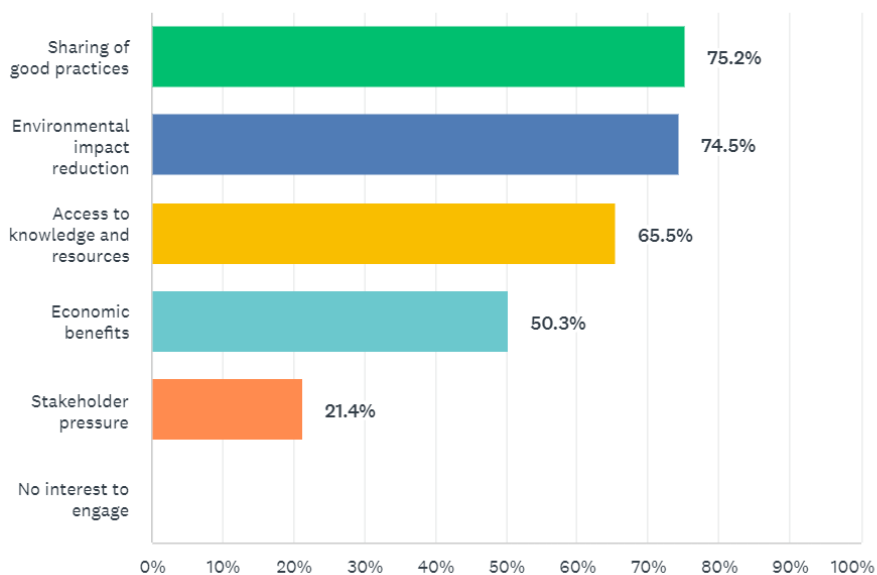
**How interested is your company/association in shaping and participating in a GFC Implementation Programme focusing on industry engagement and action?**

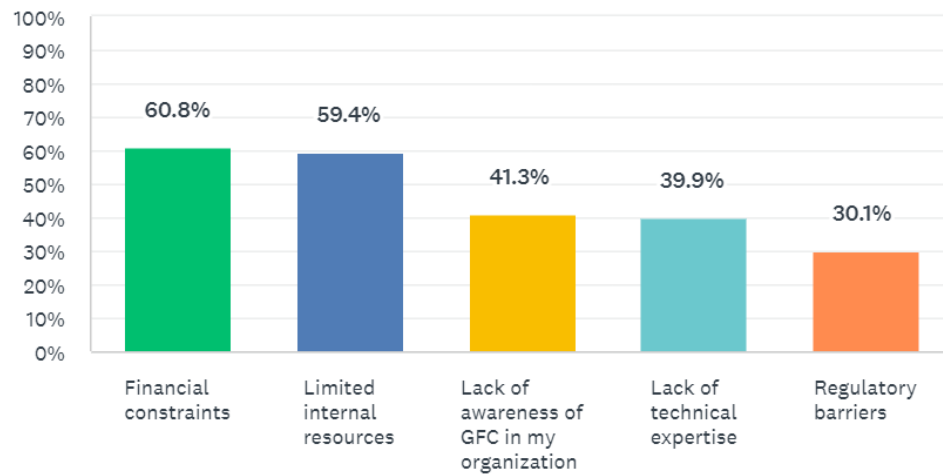

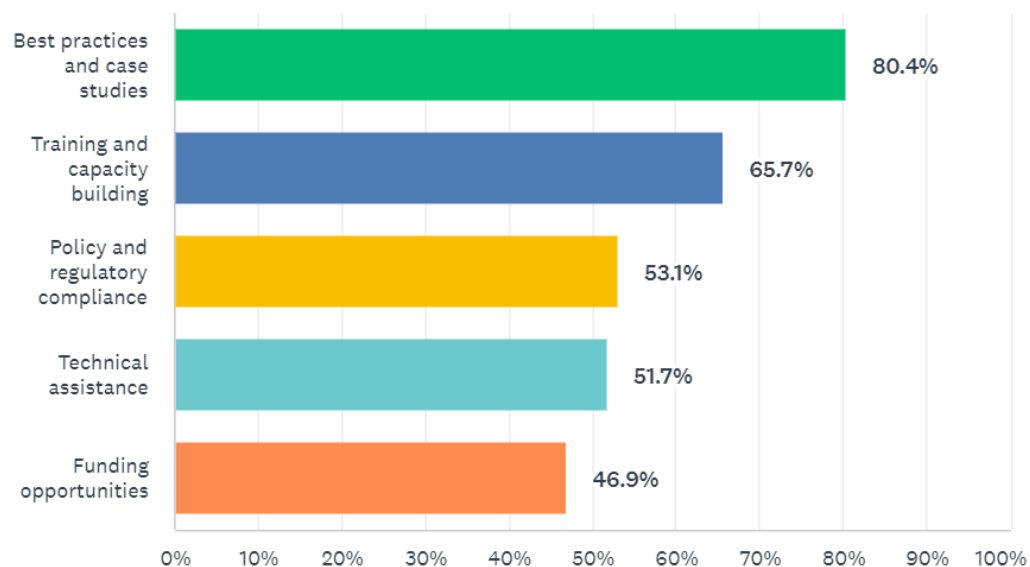
**What potential challenges do you foresee in contributing to an GFC Implementation Programme on industry engagement and action (Check all that apply)**

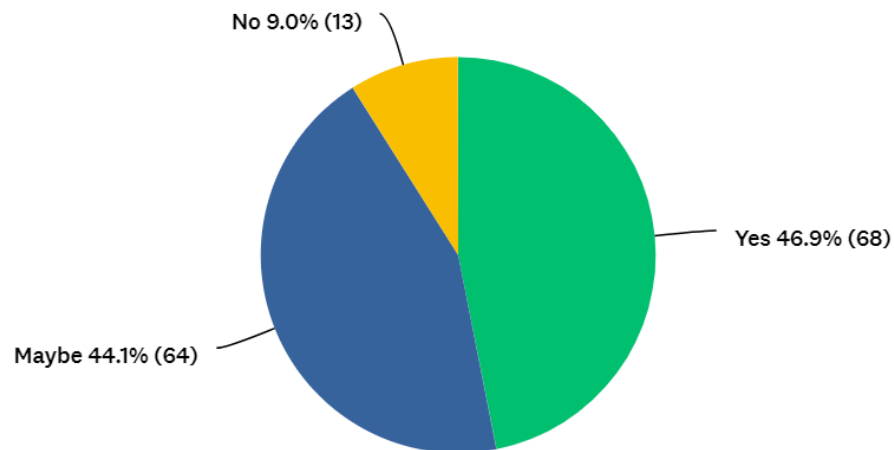

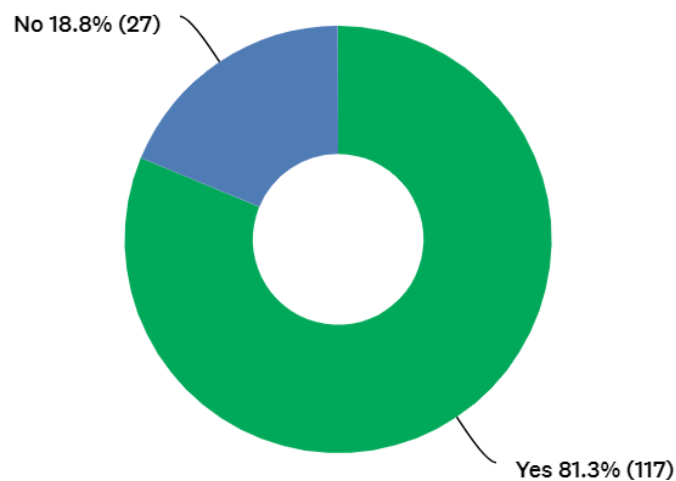
